National USPAP Update Course is a one-day update course, copyrighted by The Appraisal Foundation, that focuses on recent changes to USPAP requirements for ethical behavior and competent performance by appraisers. This course, which clarifies several commonly misunderstood aspects of USPAP, will aid appraiser in all areas of appraisal practice seeking updated competency in USPAP, including those subject to state licensing or certification and continuing education requirements imposed by professional organizations, client groups, or employers.

NOTE: The Appraisers Qualification Board (AQB) of The Foundation has issued a statement that indicates effective 01/01/2005 an appraiser must successfully complete the 7-hour USPAP program every two years to meet the state’s Standards requirement.

The appraiser can take the 15-hour USPAP but it will only count for hours toward his state’s continuing education requirement or pre-licensure; the 15-hour program will not meet the USPAP requirement for the one-day update course required every two years for state licensed appraisers.
