COURSE CONTENT: Developed by William “Ted” Anglyn, MAI, this 7-hour seminar is a must if you own, broker or appraise income producing real estate. This seminar provides critical insights on how to forecast rent levels, vacancy, and additional sources of revenue on all income-producing types (commercial and residential). Key issues with analyzing rent rolls and forecasting rent on vacant space is the foundation of the program. Discussions on how to quantify and consider vacancy and concessions as well as other forms of revenue “other income” are presented. The seminar ends with two case studies (one residential and one commercial) that exemplify the value of forecasting revenue.
